Purpose

To promote a better understanding of religious freedom in the context of a secular society.

Goals of the Congress

1. To study the interaction of the practice of religious freedom and secular society from a holistic perspective, taking into account a wide range of disciplines including theology, law, history, political science, and philosophy.
2. To examine ways of reaffirming the commitment to maintaining religious freedom as enunciated in Article 18 of the Universal Declaration of Human Rights.
3. To explore strategies for sharing the importance of maintaining the religious freedom of the individual.
4. To prepare a statement on Religious Freedom in Secular Societies.

From the IRLA Declaration of Principles

We believe in the natural and inalienable right of freedom of conscience—to have or not have a religion; to adopt the religion or belief of one's choice; to change religious belief according to conscience; to manifest one's religion individually or in community with others in worship, observance, practice, promulgation, and teaching—subject only to respect for the equivalent rights of others.

We believe that religious liberty and the elimination of intolerance and discrimination based on religion or belief are essential to promote understanding, peace, and friendship among peoples. We believe that citizens should use lawful and honorable means to prevent to reduction of religious liberty.

We believe that the spirit of true religious liberty is epitomized in the Golden Rule: Do unto others as you would have others do unto you.



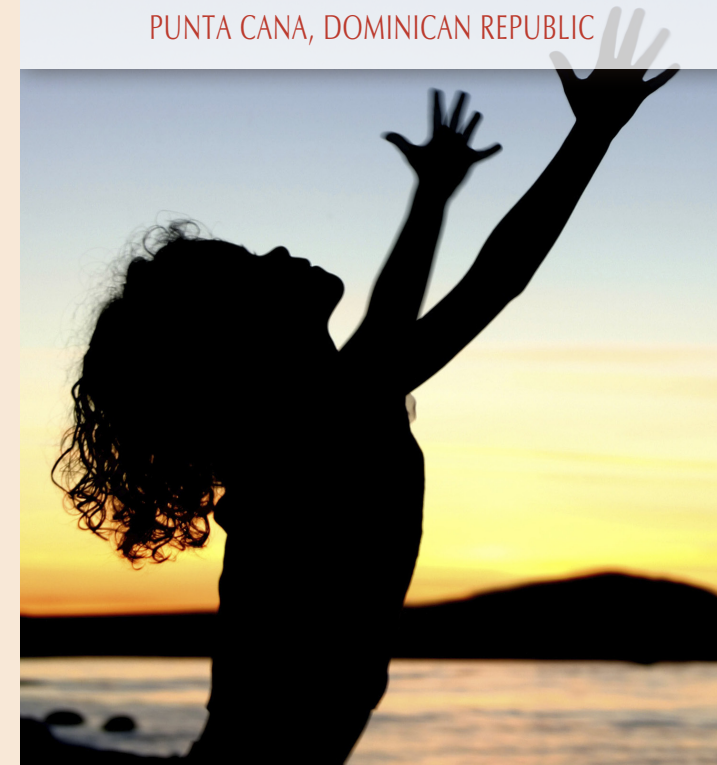

Program

The World Congress will consist of 12 plenary sessions, and 54 papers will be presented in six parallel sessions. More than 30 experts, religious leaders, and government officials will make presentations.
