The third edition of the UNEQUAL World International Conference was attended by 80 participants from 25 countries, including speakers from academic research community and international organizations. Speakers from international organizations, top researchers, diplomats, and academics from various cultural, religious, and political backgrounds gathered at the UNEQUAL World Conference to share their experiences and exchange their research findings on current issues that impact our society.

The conference's topic was *Integrity, Freedom, and Trust – A Comprehensive Understanding of Corruption and Its Effect on Human Rights*. The International Anti-Corruption Day is observed on the 9th of December every year all across the globe. According to the United Nations, corruption adversely affects all human rights, since they are interdependent and indivisible.
